2. Supplier should furnish a written request and a receipt issued by the Accountant of Sri Jayewardenepura General Hospital for the payment of Registration fee of **Rs. 2,500.00** by cash for each category to collect the application. Applications should be sent under registered cover addressed to the Chairman, Sri Jayewardenepura General Hospital, Thalapattpitiya, Nugegoda, marked "**Registration of Suppliers for year 2025**" on the left hand top corner of the envelope. Application for each category should be sent under one cover indicating the category of supply applied for on the envelope on or before. **20.02. 2025.**
3. For all categories in group A,B,& C all interested applicants should get registered for the year 2025 regardless of the previous year registration.
4. Normally quotation called with registered post or via e-mail. There for correct address and e-mail address should be mentioned.

5. Registration will be done after verification of particulars given in the applications, applications submitted with inadequate information will be rejected.
6. For categories under GROUP C, NATIONAL MEDICINES REGULATORY AUTHORITY CERTIFICATE (NMRA) will be considered .Applications with Pending NMRA will be accepted, provided that, it will be handed over within reasonable time.
7. All applicants seeking registration should grant at least 30 days credit facility and goods to be delivered to Hospital Stores.
8. Quotations will normally be called from the list of registered suppliers, but the Sri Jayewardenepura General Hospital reserves to itself the right to obtain offers / quotations and make purchases from outside the registered list as well, when necessary.
