- 4. If the item for which you have quoted is not available with you to deliver soon, please state the period of time that will be taken to deliver the goods to the Hospital. (Unless this is stated, quotations will not be accepted).
- 5. Quotation should only be in Sri Lanka Rupees. Unless requested to quote or CIF price. (If quoted in foreign currencies quotations will not be accepted).
- 6. No advance payment will be made by the Hospital.
- 7. Payment for the goods received will be made after a period of one month if you deliver all items in given period.
